Description:

The Ohio State University invites applications for an Assistant Professor, tenure-track, to serve as The Lawrence and Isabel Barnett Endowed Assistant Professor in Arts Management/Entrepreneurship. This assistant professor will reside in the Department of Arts Administration, Education and Policy and the Barnett Center for Integrated Arts and Enterprise and have a research focus on Arts Management and/or Arts Entrepreneurship. The ideal candidate will have a strong interest in supporting student learning in arts entrepreneurship and management—including students who may come from an arts performance/production focus or a general administration or business focus—in the spirit of the intention of Lawrence and Isabel Barnett to teach art students about business and teach business students about managing arts organizations. We seek an assistant professor of arts management/entrepreneurship whose scholarship, inclusive of research, teaching, and work experience, shows promise for developing into national and international expertise within the arts management/administration field. This position is crucial to expanding the breadth of disciplinary expertise and programmatic offerings within the Department of Arts Administration, Education and Policy due to substantial growth in student interest. The successful application will contribute to the following thriving department programs and Center:

- Barnett Center for Integrated Arts and Enterprise;
- Bachelor of Arts in Arts Management, in cooperation with the Fisher College of Business;
- Master of Arts in Arts Policy and Administration, a joint program with the John Glenn College of Public Affairs;
- Undergraduate Minor in Arts Entrepreneurship; and
- Proposed (under review) Graduate Minor in Arts Management.

The successful applicant will teach both undergraduate and graduate courses, and take an active role as an instructor and advisor to students at all levels. An existing research agenda that reaches across traditional disciplinary boundaries is desirable, as this position offers opportunities for collaboration with faculty in other departments across the College and University, including the Fischer College of Business and John Glenn College of Public Affairs.

Scores of graduate students have been awarded Barnett fellowships in the Department of Arts Administration, Education and Policy. The family has also supported the Barnett Symposium bringing arts leaders from around the world to campus and featuring speakers from actor Robert Redford to former Chair of the National Endowment for the Arts Jane Chu. In September 2014, the opening of the Barnett Center for Integrated Arts and Enterprise in the renovated and restored Sullivant Hall was celebrated alongside the new state-of-the art Barnett Theatre in the Department of Dance.

Qualifications:

PhD in Arts Administration, Business Administration, or related field, promise of a teaching/publication record that will become national/international in scope, and demonstrated innovative and experimental approaches to education are required for the position.

About Columbus:

The Ohio State University campus is located in Columbus, the capital city of Ohio. Columbus is the center of a rapidly growing and diverse metropolitan area with a population of over 2 million.
