RESEARCH IN PROGRESS

Working Across the Creative Sector: Portfolio Careers and Professionalization. Co-editing a book manuscript and contributing one chapter and co-authoring two more. The seed of this project was sown in research and discussions around the 2003, 2004, and 2006 Barnett Symposia. The volume reconceptualizes how we understand the worklife of those in the creative sector. As such it combines aspects of theoretical, methodological, and economic aspects of cultural policy as well as of arts management and entrepreneurship. It explores how the perspective on working in the arts changes as attention moves from the nonprofit arts to the creative industries and the creative sector. Two major aspects of this shift are examined: portfolio careers and professionalization. Variables used to explore patterns of and propensity for portfolio careers include: (1) institutional settings (for-profit, nonprofit, informal, arts education, embedded in non-arts organizations); (2) mix of occupations (arts, arts-related, and non-arts); (3) production function (creating, technical, administrative, presenting/performing/exhibiting, supporting infrastructure); (4) artistic field/industry; (5) career stage; and (6) geographical location. The patterns of portfolio careers as well as training/educational trends in specific arts and arts related occupations will be used to assess the processes of professionalization in the creative industries. The findings on both portfolio careers and professionalization will inform the discussion of possible ramifications for the education of the cultural workforce, for the acquisition of repertoire of skills (including entrepreneurship) and for cultural policy.
